### Personal precautions, protective equipment and emergency procedures

### Methods and materials for containment and cleaning up

### Precautions for safe handling

**Conditions for safe storage, including any incompatibilities** : Store in accordance with local regulations. In acute and sub-acute studies involving exposures to lower concentrations of mineral oil mists at or near current work place exposure levels produced no significant toxicological effects.
