Consumer receives check payable to Installer for use on their next visit.</li> </ol> <b>Submissions on behalf of the Consumer by the Installer are not permitted.</b> \$3 Synthetic Blend oil changes, \$5 High Mileage oil changes, and \$7 Full Synthetic and dexos1® oil change. <b>DuraMAX Liquid Armor Engine Warranty Program</b>	The Liquid Armor Engine Warranty gives the Installer retention tools and e-marketing capabilities: <ol style="list-style-type: none"> <li>1. Service reminders are sent every 120 days (3 per year) to customers who enroll in the Warranty.</li> <li>2. Installer receives two (2) free email marketing campaigns each year (campaigns do not roll over year to year). Additional campaigns can be purchased for \$50 plus \$0.05 per email.</li> </ol> DuraMAX oil must be used for the Liquid Armor Engine Warranty.
